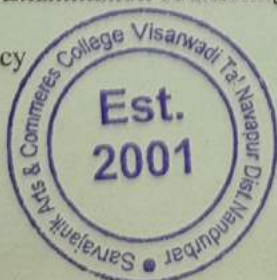

#### **Deliverables from the Gram Panchayat Office**

2. Providing platform to our students to undergo short projects and government policies in interest of public.
3. Organizing events for the promotion of environment awareness and digital literacy.
4. Help college to promote Sustainable Development Practices

#### **Deliverables from the college**

1. The College will organize different programmes as prescribed by the government and affiliating university for promotion and creating awareness among village peers.
2. Motivate youth and children of the village to study for competitive examinations and help fraternity in facilitating digital literacy and field surveys.
3. Assistance in all the social welfare programmes organized by the Second Party. Logo on all online and offline modes of promotion of the event jointly organized by the college and Panchayat.
4. Placement counseling to those youth who have pursued skill based training programmes.

#### **MODE OF OPERATION**

Both parties will provide necessary support for effective implementation of the MoU within the institutional rules and procedures.

This MoU shall be effective from the date it is signed by both the parties.

Within the broad frame work of the MoU, Gram Pachayat Office Mothe Kadwan Tal Navapur and Sarvajani College (K.B.C.N.M. University Jalgaon), can work on awareness activities, Placement counseling, development of facilities etc.

Where possible and appropriate, the parties may also seek funding for collaborations from Government and related agencies.



#### AMENDMENTS/MODIFICATIONS




